FINANCIAL INFORMATION

2022 financial results reflect an operating loss of \$2.4 million compared to a \$2.2 million loss in 2021. Although our census numbers improved over 2021, our Medicaid population numbers remain high with state Medicaid reimbursement continuing to fall short of covering the daily cost of care. Our 2022 operating expense increase over 2021 correlates somewhat to our increase in census but also includes approximately \$590K of agency staffing costs incurred while trying to meet the new RI state staffing mandates. Staffing and other costs per resident have continued to increase due to the intensity and complexity of care required as well as an industry-wide shortage of qualified staff. As a result of these limitations, we continue to incur more overtime pay and increased contract labor costs.

In 2022 we continued utilizing endowment funds to support operations. After \$1.7 million of withdrawals to supplement our operations in 2022, and investment losses of \$1.4 million we've ended 2022 with an endowment balance of \$5.6 million. The 2022 economic conditions did not afford us the positive investment growth as in years past. Although we will need to again tap our endowment to support our 2023 operations, our current need has diminished somewhat due to the receipt of Employee Retention Credit (ERC monies) and additional "one-time" state funding. Over the years, the generosity of the Friends of the Corporation, families of past residents and many other supporters has allowed us to grow our endowment fund. One of the purposes of an endowment is to support operations in a temporary emergency such as COVID-19. Unfortunately, due to the circumstances described above, we have become too heavily reliant on using the endowment to support operations. This is not a fiscally prudent long-term practice and must be dealt with soon. As such, your Board and senior management are spending significant time considering several strategies to sustain our endowment to ensure our future.


ANNUAL APPEAL 2022
